If Bigelow Oil Company, Inc. has to refer my account to collection for any amount I owe, to a lawyer or collection agent who is not a salaried employee of Bigelow Oil Company, Inc., I agree to the extent permitted by law, to pay reasonable attorney fees and court costs.

\*Any discount given regarding oil pricing will be lost when accounts are past due on agreed pricing terms. Customers will be charged full retail price per gallon on the day of delivery.
